Milk- and wine vinegar-based
Thixotropic finishing mortar



Field of Application

Applying dehumidifying finishing coating on-site to the interior walls of buildings and insulating anti-crack coating to exterior walls.

How to apply

Dehumidifying Coating of Interior Walls

The approximately 2mm **interior dehumidifying double layer** micro-coating is made as follows:

1. Using a roller without water, apply an initial coat of Primer Ecobios LIB;
2. Install a 45g/m² glass veil anchored with 1 coat of Primer Ecobios LIB, applied using a roller without water;
3. Using a hand trowel, apply 1 coat of no less than 500g/m² of TIXOS (in addition to the plaster), mixed with 30% alabaster plaster;
4. Using a roller without water, apply a second coat of Primer Ecobios LIB;
5. Using a hand trowel, apply a second coat of no less than 500g/m² of TIXOS (in addition to the plaster), mixed with 30% quick-drying alabaster plaster;
6. Using a roller without water, apply a third coat of Primer Ecobios LIB;
7. Using a roller without water, apply 2 coats of Solaria Universal ES milk- and wine vinegar-based mineral paint.

Insulating Coating of Exterior Walls

The approximately 2mm **exterior insulating double layer** micro-coating is made by replacing the quick-drying alabaster plaster with quick-drying concrete and completing the micro-coating with 2 coats of EcobioSun **silky** and/or **El.i.T.** using a roller and/or spraying it on. Air out (7÷20 days) before spending time in the treated rooms.
